Open House Project Update Meetings – March 2020

Please join us at one of the upcoming Open House Meetings

The California High-Speed Rail Authority is conducting a series of Open House Meetings for the Burbank to Los Angeles (B-LA) Project Section. The Section is part of the first phase of the nation's first high-speed rail system. The Section is approximately 14-miles connecting Burbank (airport area) and Los Angeles Union Station, running mostly within the existing railroad corridor adjacent to the Los Angeles River. The meetings provide the public with an update and opportunity to review and ask questions about the B-LA Preferred Alternative being studied to help prepare for the formal release of the Draft Environmental Impact Report/Environmental Impact Statement (Draft EIR/EIS) expected in May 2020. Project features highlighted at the meetings will include grade separations, stations, local safety improvements, etc.

These project update meetings will also provide stakeholders with information on where to access the environmental documents and how to participate in the public comment process when the document is released anticipated in May 2020.
